- E. The Incoming Trustee mentioned above shall hereinafter be appointed as a Trustee of the Trust. The Trustee No.1, Trustee No.2 and Trustee No.3 have co-opted and appointed the Incoming Trustee Mr. Arvind Ankanahally Manjegowda w.e.f 13.01.2016 in the Board Resolution dated 13.01.2016.
- F. Wherefore, the Trustee No.1, Trustee No.2, Trustee No.3 and the Incoming Trustee alone are the Trustees of the Trust and shall be vested with the powers and responsibilities to carry on the activities of the Trust without any let or hindrance.

NOW THEREFORE THIS SUPPLEMENTAL DEED WITNESSETH AS FOLLOWS:

- 1) The parties have mutually agreed that in addition to the terms and conditions contained in the Deeds, the terms and conditions contained in this Supplemental Deed shall be effective from the 13.01.2016.
- 2) Clause 4 of the Amended Trust Deed is hereby substituted and replaced with the Clause below, which shall hereafter read as:




